She/He shall keep the Rhode Island State President informed of all such Legislation, with a synopsis of the effects, both, Pro and Con, said Legislation would have on Labor. She/He shall, be a Liaison between The Rhode Island State APWU President and all Legislators at the National, State and Local levels of Government. She/he shall at the request of the Rhode Island State APWU President, assist the President in all matters requested; this in keeping with the duties described above...*

**Then Add the follow to Article IX Sec 6:**

**(d) All Craft Directors and the Legislative Director shall be paid a salary of \$150.00 (One Hundred Fifty Dollars) Annually....**

**(e) The Web Administrator shall be a paid a paid a salary of \$100.00 (One Hundred Dollars) Annually.....**

**(f) The Three (3) Trustees shall be paid a salary of \$75.00 (Seventy-Five Dollars) Annually....**
